Offers are invited in two bid system, from reputed manufacturers of ISI marked edible Iodised salt, for supply in 1 Kg packing on delivered basis in MP state and Tribal area of Rajasthan from Gujarat, as under:-

Sub: - Supply of Iodised Salt (ISI marked) packed in 1 Kg. Polyester laminated bags with master pack of 50 packets in HDPE bags, on delivered basis at respective block level godowns in six districts (SIROHI,UDAIPUR,BANSWARA,CHITTOGARH,DUNGARPUR AND BARAN) in Rajasthan.

INTRODUCTION

Hindustan Salts Limited invites offer for arranging supply of Iodized Salt (ISI Marked) packed in 1 Kg Polyester laminated bags with subsequent packing in 50 Kg HDPE bags on delivered basis at various block level godowns in six districts of Rajasthan. Reputed experienced manufacturer of ISI marked salt may submit their offer in two bid system i.e (Part -I consisting of Technical Bid and Part-II consisting of Price Bid).

Technical Bid

1. The bidders should submit their Technical Bid in sealed envelop and they should mention on the envelop as "Technical Bid".
2. The bidders are required to submit following documents along with the tender:-

A. Earnest Money Deposit:-

Bidders should submit an EMD for Rs.3.50 lakhs (Rs.Three lacs fifty thousand only) in shape of DD in favour of Hindustan Salts Limited, payable at Jaipur Or FDR of any scheduled Bank duly pledged in favour of Hindustan Salts Limited, Jaipur on account of tenderer.

B. Cost of Tender Documents:

In case, the tender form is downloaded from the website, bidders should deposit Rs.1000.00 in shape of DD in favour of Hindustan Salts Limited, payable at Jaipur. Or in cash before submission before due time of submission of the tender.

C. Bidders should have valid & operative BIS licence and experience for the manufacturing & packing of ISI marked iodised salt , which shall be arranged in company's premises at Kharaghoda, Distt. Surendernagar, Gujarat. The party is required to arrange required quantity of standard salt at our company's premises, supply of Polyester Laminated pouches as per requirement/standard/design for the packing of BIS marked Iodised salt, required new HDPE bags for master packing of 50 packets, arranging crushing/sewing/processing/ packing of salt in company's premises and transportation/delivery of salt at destination as per program of our principal buyer as per list attached. The schedule of supply of our principal buyer shall be adhered strictly. However in the case of necessity the dispatches of BIS marked Iodised Salt may be arranged from party's premises. Copy of party's BIS license be enclosed with the technical bid.

D. Name and address of the Bankers, the Bank Account Numbers (including type of account i.e. saving/Current or others) of the Tenderer and the year since the Account is being operated.

Price Bid

- (i) The bidders should submit their price Bid in sealed envelop and they should mention on the envelop as "Price Bid".
- (ii) The price bid of only technically qualified bidders will be opened.
- (iii) Offers sent by fax and unsealed conditions will not be entertained.

Special terms and conditions

1. Bidders should submit their offer on delivered basis at all the godowns in six districts as per list enclosed .The rates should be quoted in quintal.
2. Bidders are required to quote the rates for arranging supply of ISI marked Salt. The experienced parties having valid & operative BIS licence, may submit their offer for arranging manufacturing and supply of ISI marked salt from our company's premises at Kharaghoda, Distt. Surendernagar, Gujarat. Required space for storage of salt, packing of salt and storage of finished product, will be provided by the company free of cost but electricity consumption shall be charged on actual basis.
3. The successful Bidder is required to deposit Security Deposit @ 3% of contract value in shape of DD in favour of Hindustan Salts Limited, payable at Jaipur. the EMD deposited will be converted in Security deposit. Security deposit shall be kept with the company for the successful completion of the contract.
4. The successful bidder would require to supply salt as per requirement of our principal buyer.
5. The validity of the offer should be for 90 days from the opening date of the tender.
6. The bidder should submit their rates after through study of the road conditions of Rajasthan.
7. No interest is payable on the EMD/SD deposited by the bidder.
8. All taxes if any will be the liability of the supplier.
9. In case of failure, the supplies will be arranged on the risk and cost of the supplier.
10. The penalty imposed by our principal buyer on account of quality of salt, quality of packing material as well as late delivery shall be deducted from the bills of the supplier.
11. The rate contract can be extended for the period of three months, after expiry of the validity of the rate contract, by mutual consent and the successful bidder will be binding for the same.
12. The iodine content in the salt should be 30PPM at the time of packing and should not be less than 15PPM after six months or at consumer's end.
13. The salt should be pure, clear, white, granular and as per PFA act and ISI marked with following specifications.

The specification of Iodised salt as per PFA is as under:-

A.. Sodium Chloride, percent by wt. min	96% minimum
B. Matter insoluble, in water per cent by wt. Max.	1% maximum
C. Matter soluble in water other than Sodium Chloride percent by wt. Max	3% maximum
D. Moisture by weight of the undried sample Max	6% maximum
E. Iodine at	
(a) Manufacturer's level ppm min.	30 ppm
(b) Distribution channel including retail level ppm min.	15 ppm

or

At manufacturers level- Not less than 30 ppm of iodine, i.e. not less than 50 ppm of potassium iodate.

At consumers end - Not less than 15 ppm of iodine i.e. not less than 25 ppm of potassium iodate.

Anti Caking Agent : Permissible to be added as per ISI requirement.

The salt will be supplied in 1 Kg Polyester laminated 55 micron bags. The poly pack will be in three color, transparent and as per the design given by HSL.

The successful bidder would require to supply 500 empty polyester bags along with transportation.

14. The supplier should stamp date of packing on the pouches.
15. In case the packing material, ink of printing and quality of salt is not as specified, the payment may be withheld and EMD/SD may be forfeited.
16. Payment will be released as under:-
 - a) The supplier shall be required to submit the following documents along with the bill. A) Truck Challan B) Copy of weighment slip. C) Salt Commissioner's (Govt. Of India) quality certificate E) Certificate of salt receipt from respective district godowns, through Tehsildar office along certificate, to enable the company to raise the bills to our principal buyer.
 - b) The payment to supplier shall be released within 5 days from the date of receipt of payment from our principal buyer.
17. The successful bidder is required to supply the salt as per the supply schedule of the corporation. Otherwise a penalty imposed by our principal buyer will be charged.
18. Tender received after due date and time as mentioned in the tender document will not generally be entertained.
19. After submission of tender by the tenderer the withdrawal of same will not be allowed at any point of time.
20. The Hindustan Salts Ltd. reserve the right to accept in its sole and unfettered discretion any tender for whole of part quantities or to reject any or all tender without assigning any reason therefore.
21. The Hindustan Salts Ltd. does not bind itself to accept the lowest tender or assign any reason for non-acceptance of the same.
22. If required, negotiation may be held only with the lowest tenderer.
23. A contract arising, on acceptance of this tender or in consequence of this tender, the company and the tenderer, agreed to abide by the terms & conditions of these tender documents as well as the terms and conditions mutually agreed in writing between the parties.
24. The Company shall mean Hindustan Salts Limited at its registered office at B-427, Pradhan Marg, Malviya Nagar, Post Box No.146. JAIPUR-302017.
25. Each page of the tender documents is required to be signed by the Tenderer.
26. Arbitration clause:-
 - a) In the event of any question, dispute of difference whatsoever arising under this contract or in connection therewith including any question relating to existence, meaning and interpretation of this contract or any alleged breach thereof, the same shall be referred to the Sole Arbitrator, Chairman & Managing Director, Hindustan Salts Limited or to any officer of the company appointed by him for the purpose. The arbitration shall be conducted in accordance with the provisions of the Arbitration and Conciliation Act., 1996.
 - b) It will be no objection that the Arbitrator is an interested person and/ or that he had to deal with the matters to which the contract relates and/ or in the course of his duties he has expressed any view on any matter in dispute of difference. The award of Arbitrator shall be final and binding on both the parties.
 - c) In the event of Arbitrator dying, neglecting, resigning or being unable to act for any reason or his award being set aside by the court for any reason, it will be lawful for the Chairman & Managing Director of the Hindustan Salts

Limited/Sambhar Salts Limited to appoint another Arbitrator in place of outgoing Arbitrator.

- d) The Arbitrator may from time to time, with the consent of all parties, enlarge the time in making the award.
- e) The cost incidental to the arbitration shall be at the discretion of the Arbitrator. The arbitration shall be conducted at Jaipur(Rajasthan) or at such other place or places as the Arbitrator may so decide.
- f) Notwithstanding any disputer between the parties supplier shall not be entitled to withhold/delay or defer his obligations under the contract and the same shall be carried out strictly in accordance with the terms and conditions of the contract..

27. Penalty:-

In case of any default by the supplier, the company shall be entitled to get the contract executed by alternative means and if for that purpose the company is required to incur additional expenses or substantial financial loss, the same shall be recovered from the defaulting supplier, apart from levying liquidated damages, penalty, interest etc., as may be deemed appropriate by the company considering fact & circumstances of the case.

28. Jurisdiction

In case of any disputes which remained unresolved in arbitration proceeding shall be referred in the appropriate court of law at Jaipur(Rajasthan) only.
